# Illinois Fall Rally Springfield, IL October 2, 3, 4, & 5, 2010

The Dixon's, Woare's, Skalski's, Scarlett's, Jim White and Marilyn Smith invite you to the last rally of the Great Lakers 2010 season. A number of you will be attending the GMC International Convention in Du Quoin, Il. Our October rally is scheduled to begin after the GMCMI convention ends so that many of you traveling back North will continue to enjoy the "The Land of Lincoln" in Springfield, the state capital of Illinois. The city is located about 157 miles from Du Quoin. The campground is located at the Illinois State Fairgrounds. Some Great Lakers have indicated that they will not be going to Du Quoin but will attend the Springfield rally. Some members from the GMC Greater Mid-West Classics may be joining us as well.

There is much to see in Springfield including the Abraham Lincoln Presidential Library in the downtown area; Shea's Gas Station Museum; the Dana-Thomas House - said to be one of the largest and most elaborate of prairie-style designs of the world famous architect Frank Lloyd Wright; and the Executive Mansion - the official residence of Illinois governors since 1855. This is a partial list of many more places to explore. We will have coffee, donuts, juice, etc. for the mornings. On Saturday, lunch and dinner will be on your own followed by an ice cream social back at the campground in the evening. On Sunday evening we will have hot dogs, chips, salad and other goodies. The catered meal of chicken, beef, and fish as well as vegetable and desert items will be on

the menu for Monday evening.

#### **DIRECTIONS:**

The Illinois State Fairgrounds is located in the northern part of the Springfield near the Capital Airport. I-55 loops around the city. However, take I-55 BUS to get to the fairgrounds. The campground is at the corner of Sangamon Avenue and N. 8th Street (Entrance #11).

Those who wish to arrive early should proceed to the campground office and register. Tell the office staff that you are with the GMC Great Lakers group. The camping fee is \$20 per night for 55 and older. Those under 55 will pay \$25.00 per night. On Google maps and GPS devices make the destination: 801 Sangamon Avenue, Springfield, IL.
